

## Professional Auditors Application Form

Complete this form and submit a copy of your CV or resume if you are a professional who would like to request to enroll in a law class. Upon receipt of this form, our office will review the application and discuss with the professor of the class you wish to audit. Your application must be approved by the Registrar and by the professor involved. Please note that for limited enrollment courses, law and UH graduate students are given priority to seats in the class.

Auditors will have a University of Hawai'i record of their audit of the law school course, but they will not receive "credit" for the course. In addition, auditors are not allowed to sit for an exam in the course, nor will they be graded on their participation in the course. Auditors will be required to pay for the course, by the credit hour, according to the current **law school tuition schedule** at [www.law.hawaii.edu/tuition](http://www.law.hawaii.edu/tuition).

Under the Standards of Legal Education set forth by the American Bar Association, the Law School may allow the enrollment of non-law graduate degree candidates, provided that their enrollment does not adversely affect the quality of the course or the law school program. The Law School further prohibits non-law students from taking courses that are part of the first-year curriculum.

The American Bar Association absolutely prohibits non-law students who subsequently enter a JD program from transferring any previously earned law school credits to the student's JD degree.
